#### TC1625 To agree the Minutes of the Meeting held on 22<sup>nd</sup> June 2015

The Minutes were agreed as a true record. Cllr Redding expressed concern that her apologies had not been recorded.

## TC1627 Adjournment for Public Participation

A resident asked what progress had been made in getting Complete Boule back to rectify the surface of the boule court and whether a private application could be made to the County Courts. The Council explained that due to Mr. Rumble's reluctance to accept fault with the surfacing quotations/reports would be obtained and depending on the cost an application for redress might be made if appropriate. The resident requested that a rake be chained to the railings to provide a means of preparing the surface for play (ART Committee) Councillor Brine asked the Council to look for another location for the defibrillator because the Co-op were taking too long to decide a nationwide policy on the matter. (ART Committee)

TC1628 To receive brief written reports from County/District Councillors on matters of concern to Stonehouse

Councillor Gary Powell requested that the agenda item should read verbal reports as he did not think Councillors had time to prepare in writing.

Councillor Williams expressed concern about delay in getting anything done on the High Street, surface dressing etc which was all weather dependent and department lacked staff. Cllr Vernon Smith was portfolio holder and complaints should be addressed to him. Gloucestershire have made a bid for devolution which will mean control of the budget for matters such as health and social care. Councillor Kambites questioned the democratic balance and was advised there would be a negotiating team to take things back to a politically balanced board. Councillor Brine reported on changes to the waste collection services with a fortnightly collection and charges for green waste collection. Councillor Ross reported that Stroud District Council also involved in devolution consultation. She explained that tenants would get a 1% cut in rent but this has changed Stroud District Council's 5 year plan, and the Right to Buy affects housing in Trust. There will be a budget meeting next week. Both District Councillors expressed annoyance that they had not been invited to a meeting to discuss repairs to the High Street taking place between Town Council representatives and County Council Highways representatives on the 9th September. Councillor Brine stated that the Town Council did not know all the history of the project and would not understand how to resolve it. Following discussion it appeared that there was insufficient attendance level for the meeting to proceed and this would be re-scheduled.

#### TC1629 To receive Chairman's report and External Representative Reports

Councillor Watt had attended the Stonehouse Celebration Day although she had not been officially invited. Cllr Byrne reported that she has been appointed to the Steering Group of Stonehouse Community Partnership. Councillor Redding reported that she had attended Standish Partnership Board meeting in August and the site was now on the market, preferably to find a bidder for the whole site.
