DC/113 PLANNING APPLICATIONS REQUIRING TOWN COUNCIL OBSERVATIONS

15/0392/FUL Upper Mills Trading Estate, Bristol Road

External and internal alterations.

This application had already been decided by the District Council – Permit.

15/0505/TPO Tree Preservation Order

Stonehouse Community Centre, Laburnum Walk Fell 3 –x Birch – direct damage to the pavement.

Comment: Reluctant to agree to felling if application was only on the grounds of maintenance issues

15/0768/FUL Land at Wharfdale Way, Bridgend

Erection of 9 dwellings with associated hard and soft landscaping.

Comment: Small accessible units are supported through the Neighbourhood Plan consultation process, however there needs to be more sympathetic design which accords with towpath/canal visitors and residents and allows visual gaps with better frontage to the canal. The stark appearance may attract vandalism. S106 needed towards links to the town.

DC/113 Planning Applications (continued)

15/0787/FUL Land at Orchard House, Pearcroft Road

Erection of new dwelling to rear of existing property and associated works.

Comment: No objection to site location but design needs modification to fit with surroundings and have less impact on street scene. In particular the roof lines needs to be reduced.

15/0966/COU Agricultural Building, Ryeford

Change of Use to mixed storage.

Comments: Concern about the mix of hay storage with possible combustible material and long term business use.

15/0983/HHOLD Fairfield, Pearcroft Road

Two storey side extension with internal alterations. New second floor window on principal elevation facing Pearcroft Road.

15/0987/TPO Tree Preservation Order

Cotswold Grange, Browns Lane

Large beech tree – reduce two low branches by up to 4 metres.

15/1032/LBC West Wing, Bridgend House, Downton Road

Listed Building Consent

- 1. Relocate existing staircase and remove (non-original) pinepannelled and stud-partion interior wall. Existing approved planning permission for something similar,
- Introduce a new staircase to allow access to the attic bedrooms, to replace existing ladder access. This will be located in existing (ladder) access position to minimise impact. Relocate small stretch of interior bedroom wall to allow wider corridor (landing) and access beyond staircase. No observations.

15/1043/LBC Listed Building Consent

Wycliffe College, Bath Road

Repairs to slate roof including re-slating, insulation, new leadworks and new rooflight to replace existing.
