

TEMPORARY CLOSURE OF VARIOUS ROADS AND FOOTPATH CLOSURES (VARIOUS PARISHES) STROUD DISTRICT

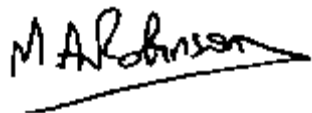
The reason for the said closures is for Virgin Media infrastructure installation work.

Further advance warnings of dates/times will be displayed on site prior to the closures taking effect. This intended Order may permit the closure of the said roads in any order, or simultaneously, as required, and it is anticipated all works will be completed by **30th March 2025**.
