

**PUBLIC PATH CREATION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER**  
**S26 HIGHWAYS ACT 1980/ WILDLIFE AND COUNTRYSIDE ACT 1981**  
**GLOUCESTERSHIRE COUNTY COUNCIL**  
**PUBLIC FOOTPATH CONNECTING FESTIVAL ROAD AND PUBLIC FOOTPATH MST10**  
**STONEHOUSE PARISH**  
**CREATION ORDER 2025**

This Order is made by Gloucestershire County Council ("the authority") under section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that, having regard to the matters set out in section 26(1), there is a need for a public footpath over the land to which this order relates, and that it is expedient that the path should be created.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that Gloucestershire County Council's definitive map and statement require modification in consequence of an event specified in section 53(3)(a)(iii) of the 1981 Act, namely, the creation (as authorised by this order) of a new right of way over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

Stroud District Council has been consulted as required by section 26(3) of the 1980 Act.

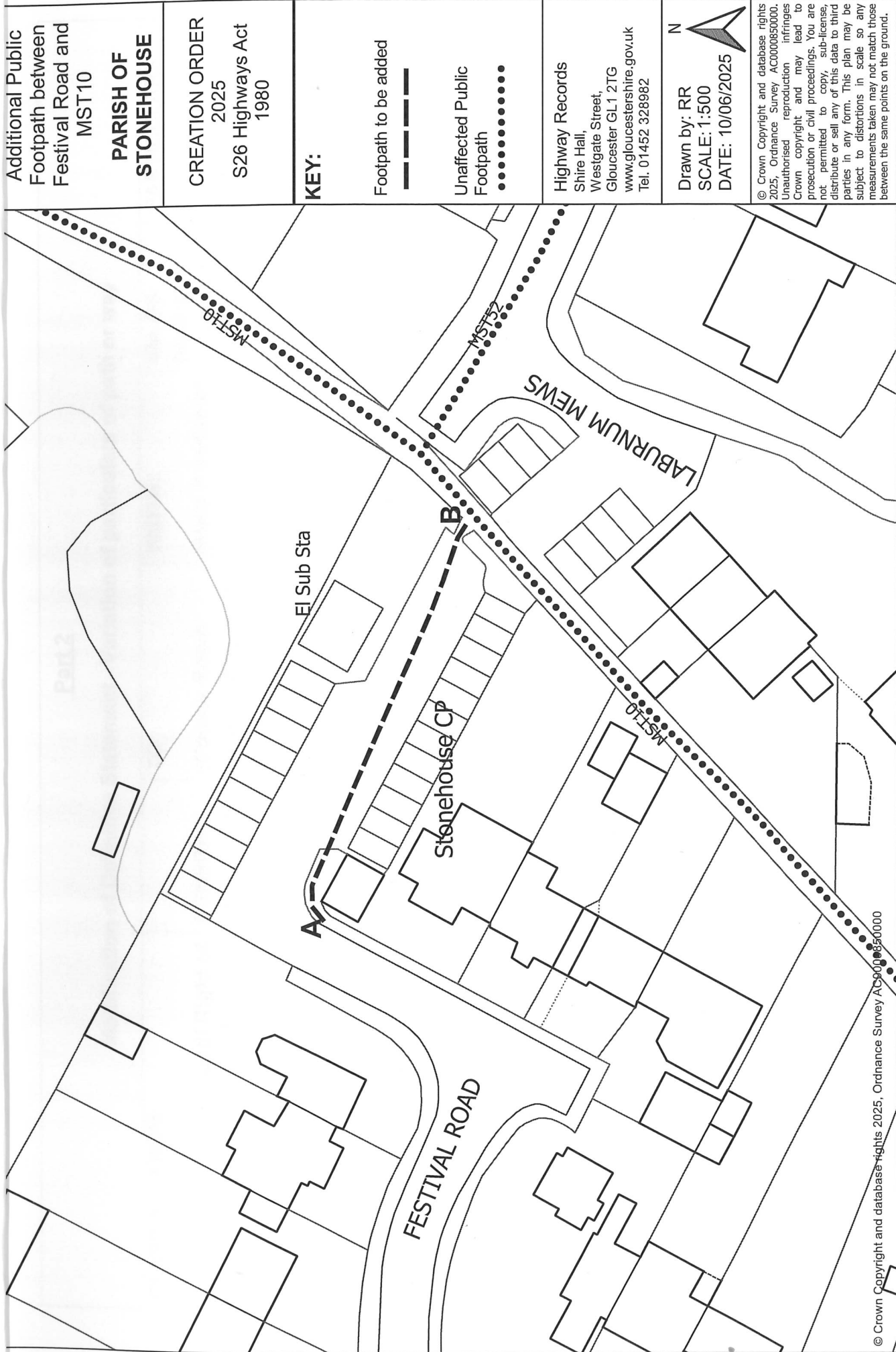
**BY THIS ORDER:**

There shall be from the date of confirmation of this Order a public footpath connecting Festival Road and Public Footpath MST10 in the parish of Stonehouse as described in Part 1 of the Schedule to this Order and shown by a bold broken line on the map attached to this Order ("the Order Plan"), and thereupon Gloucestershire County Council's definitive map shall be modified by adding the path to it, and the definitive statement shall be modified as described in Part 2 of the Schedule to this Order.

**SCHEDULE**

**PART I - Description of Land**

A length of public footpath connecting Festival Road and Public Footpath MST10 in the parish of Stonehouse in the County of Gloucestershire that commences at its junction with highway number 42483 known as Festival Road as shown on the Order Plan annexed hereto at a point marked A at Ordnance Survey Grid Reference (OSGR) SO8027/0539 and extends in an east south easterly direction for approximately 45 metres to a point marked B at OSGR SO8031/0537 at its junction with Public Footpath MST10 and being shown on the Order Plan by a bold broken black line and having a width of 2 metres.

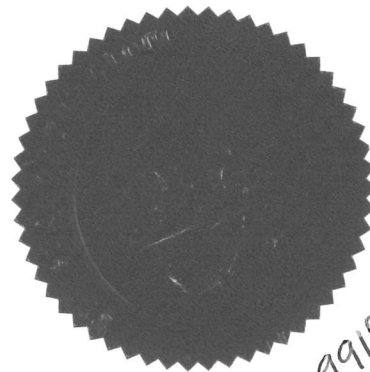
